



## Price Announcement – Far East Eastbound Europe Mediterranean to East Asia (incl. Japan), Indian Subcontinent and Middle East

March 15, 2017

In a continued effort to provide you with a high level of service and uninterrupted liner services and equipment supply, Hapag-Lloyd announces an increased FAK (Freight All Kinds) Ocean Tariff rate for all non-DG cargoes for standard container types on the eastbound trade from Europe Mediterranean to East Asia, Indian Subcontinent and Middle East.

Valid for sailings commencing on April 1, 2017 onwards and until further notice, Hapag-Lloyd's FAK Ocean Tariff rate from West Mediterranean to East Asia (including Japan) will be:

- USD 1050 per 20' Container
- USD 1450 per 40' Container

Valid for sailings commencing on April 1, 2017 onwards and until further notice, Hapag-Lloyd's FAK Ocean Tariff rate from East Mediterranean to East Asia (including Japan) will be:

- USD 1150 per 20' Container
- USD 1950 per 40' Container

Valid for sailings commencing on April 1, 2017 onwards and until further notice, Hapag-Lloyd's FAK Ocean Tariff rate from West Mediterranean to Indian Subcontinent (Nhava Sheva / Mundra) will be:

- USD 1100 per 20' Container
- USD 1600 per 40' Container

Valid for sailings commencing on April 1, 2017 onwards and until further notice, Hapag-Lloyd's FAK Ocean Tariff rate from East Mediterranean to Indian Subcontinent (Nhava Sheva / Mundra) will be:

- USD 1400 per 20' Container
- USD 2300 per 40' Container
