



## China imports and transshipments via Chinese ports

### Adjustment to China Customs Advanced Manifest (CCAM) Regulations

China Customs Authorities have released order No.2017/56, which will adjust 'Customs Advanced Manifest' requirements applicable for all China imports and transshipments via Chinese ports. The new order enforces that effective 1<sup>st</sup> June 2018 Advanced Manifest must be submitted 24 hours prior to loading.

In addition to current data required, below information will be demanded upon customers shipping instruction submission:

- Shipper's Enterprise Code and phone number
- (Optional) Shipper's Authorized Economic Operator (AEO) number

When consignee is **not** "TO ORDER":

- Consignee's Enterprise Code and phone number
- Consignee's contact person's name and phone number
- (Optional) Consignee's Authorized Economic Operator (AEO) number

When consignee is "TO ORDER":

- Notifying Party's Enterprise Code and phone
