

MSC INTRODUCES MORE SUSTAINABLE ASIA-NORTH EUROPE AND MEDITERRANEAN FREIGHT RATE FROM NOVEMBER

7TH October 2017

Dear Customers,

In the last 2 months, rates have fallen by 15 percent. Meanwhile, time charter rates have increased by 50 percent and bunker prices have surged, advancing 25 percent in the third quarter alone.

It is now widely understood that the combination of instability in our industry and, in particular, the low freight environment is both detrimental and counterproductive to a healthy balance between the BCO and FFW community on the one hand, and shipping lines such as MSC.

Left unchecked, this will only lead to further industry consolidation and service deterioration.

MSC therefore intends, in the spirit of maintaining a prime service to our respected customers, to increase rates as of 1^{st} November 2017,
