Dear Customers,

This is to inform you that as from 1<sup>st</sup> June 2018 till further notice and following the validities of MSC Freight All Kind (FAK) rates, MSC will apply a Fuel Adjustment Contribution (FAD) for shipments from Far East to the destinations referred to below.

### **FAD Levels: USD 50/TEU**
