MSC 559 - COEGA & MOZAMBIQUE SITUATION - TEMPORARY PLAN FOR CARGO EX

Paris, July 10th 2019

Dear Valued Customer,

The entire shipping industry is facing huge challenges in South Africa right now due to illegal strike actions, especially in Coega which is resulting in huge delays for all involved services.

MSC GENEVA is implementing a contingency plan in order to be able to keep our weekly service ex Europe to South Africa in place.

- Europe South Africa Service will not call in Coega until further notice.
- Angola Express will call in Coega South Bound and all Coega cargo will be loaded on this service.
   First vessel to consider is MSC Mandy ZZ929A in Antwerp PF July 15th, 2019.
- Mozambique cargo ex Europe will be moved with the Australia Service to Port Louis for further transshipment to Beira and Nacala.

First vessel to consider is MSC Barbara MA929A in Antwerp PF July 15th, 2019. Transit time ex Antwerp to Beira will be between 29 and 36 days.

Maputo cargo will be transshipped in Durban instead of Coega going forward.
