Chère Cliente, Cher Client,

Afin de répondre aux exigences des services sanitaires australiens (Department of Agriculture and Water Resources - DAWR), les conteneurs Open Top et Flat Rack en provenance d'Europe et à destination de la Nouvelle Calédonie (Noumea) doivent être soumis à une fumigation. Tout conteneur OT / FR non fumigé ne pourra être déchargé en Australie pour transborder vers Noumea.

Cette mesure d'urgence mise en place pour contrer l'afflux invasif en Australie de l'espèce Halyomorpha Halys (punaise brune marbrée - Brown Marmorated Stink Bug - BMSB) débutera le 01/09/2019 date de débarquement au 31/05/2020 date d'embarquement.
