Veuillez noter, qu'en raison des changements drastiques de la situation économique en Turquie ces derniers mois qui ont pour conséquence un fort déséquilibre entre les imports et les exports, MSC doit repositionner plus de conteneurs vides afin d'avoir assez d'équipements disponibles pour les imports provenant de la Turquie.

Afin de pouvoir absorber ces coûts, une nouvelle surcharge « Equipment Repositioning Charge (ERC) » est mise en lace et s'appliquera pour toutes cargaisons provenant de Grèce, Turquie et Mer Noire vers le West Med Contin (WMED), avec effet immediat.

MSC, Mediterranean Shipping Company, advises its clients that due to the drastic changes of the economic situation in Turkey in the last couple of months, which leads to a strong imbalance of imports and exports, MSC must reposition more empty containers to have enough equipment available in Turkey for export.

In order to absorb this cost, we are introducing a new charge, « Equip shipments from Greece, Turkey & Black Sea to West Med Continent (WMED), with immediate effect.
