En raison de la forte augmentation des volumes RAIL -ROUTE sur l'axe Bordeaux Toulouse à l'Export du port de chargement FOS-SUR-MER depuis le début de l'année, veuillez noter que nous sommes dans l'obligation d'appliquer une surcharge congestion additionnelle à tous les positionnements RAIL -ROUTE sur ces zones à l'Export rail (pour les 40' uniquement) et cela depuis le 15 avril 2019.

Due to the significant rise of volume ROAD-RAIL on Bordeaux Toulouse axis in Export port of loading FOS-SUR-MER since the beginning of the year, MSC instored an additional ROAD- RAIL congestion surcharge since April 15th 2019.
