## **NBF (New Bunker Factor\*\*) update**

**Dear ZIM Customer,**

Following the implementation of the New Bunker Factor (NBF) in February 2019, hereunder are the updated NBF levels effective from **July 1<sup>st</sup>, 2019<sup>(\*\*\*)</sup>** till further notice, applying to FAK (Freight All Kind) cargo, in the trades as detailed below.

The rates are listed below for your convenience (the data refers to ZIM's base ports in each trade):

<b>Far East to Mediterranean /Black Sea &amp; Europe</b>	<b>\$267/TEU</b>
<b>Mediterranean /Black Sea &amp; Europe to Far East</b>	<b>\$144/TEU</b>
<b>Intra Mediterranean (East &amp; West) &amp; Black Sea</b>	<b>\$148/TEU</b>
<b>North Europe and Baltic/Scand. to Mediterranean /Black Sea</b>	<b>\$205/TEU</b>
<b>Mediterranean /Black Sea to North Europe and Baltic/Scand.</b>	<b>\$90/TEU</b>

Quotations or mitigation of published surcharges that vary from ZIM's tariff shall not be binding unless included in a service contract or amendment that has been filed with the Federal Maritime Commission ("FMC") or the Shanghai Shipping Exchange, as applicable.
