Compte tenu de la congestion au port de Sydney, Australie, causée par des actions collectives impactant la productivité des terminaux, MSC Mediterranean Shipping Company est contraint de mettre en place une surcharge congestion (CGS - Congestion Surcharge) afin de maintenir le niveau de service requis.

Cette surcharge d'un montant de **300 US Dollars** par TEU sera applicable pour toutes les expéditions vers et depuis l'Europe :

- A l'import à Sydney : à partir du 14 Septembre (date proforma)

Dear Valued Customers,

Due to the congestion in the port of Sydney, Australia caused by industrial actions which are impacting Sydney's terminals productivity, MSC Mediterranean Shipping Company will apply a Congestion Surcharge (CGS) to maintain the service at the required level.

The Congestion Surcharge of **USD 300 per TEU** will be introduced for all cargo from/to Europe with the following validity:

- Import cargo to Sydney : as from 14th September (proforma sailing date)
- Export cargo from Sydney : as from 14th September (BL Date)

Any other elements of the price, as indicated in our EU Price Announcement published on [msc.com](http://msc.com) on 08th September, 2020, apply and remain unchanged. MSC is following closely the situation and will inform you as soon as Sydney port operations will return to normal.
