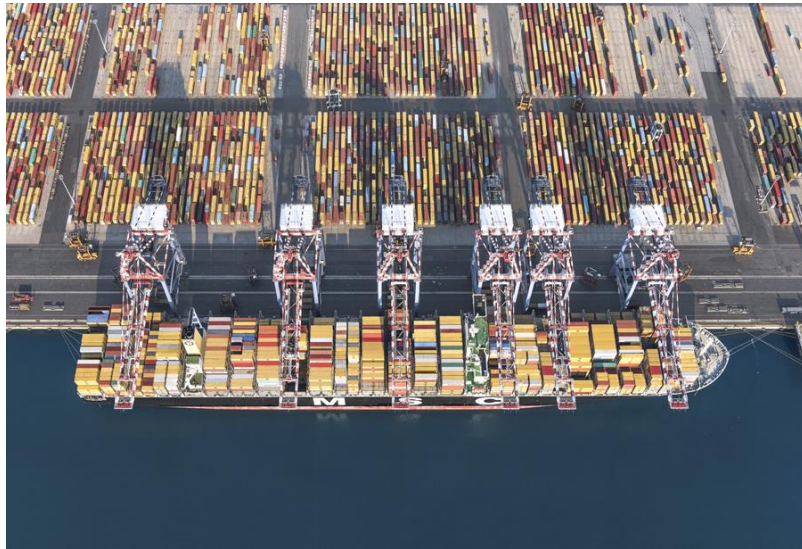

- EURO 1363 /TEU to Pacific Ocean (New-Caledonia & Tahiti)

For **REEFER** Containers

- EURO 831 /TEU to Indian Ocean
- EURO 1635 /TEU to Pacific Ocean (New-Caledonia & Tahiti)
