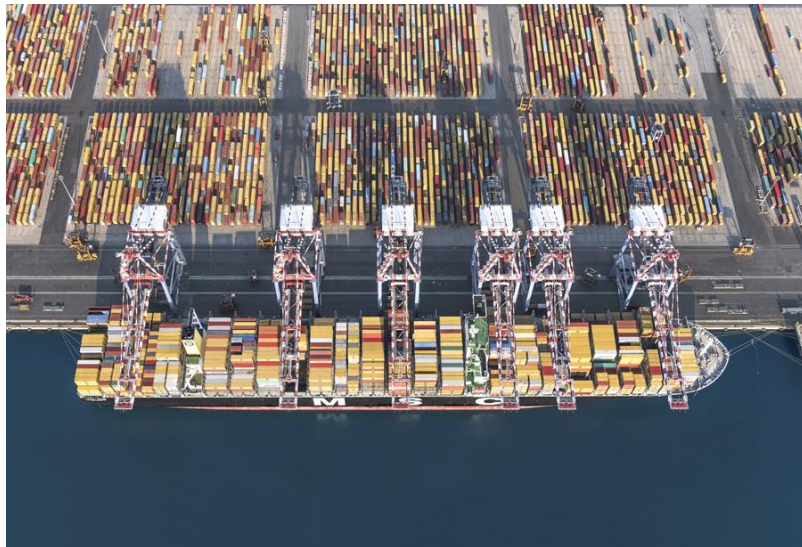

- Any misuses of contract detected (different commodities, port pairs, and/pd accounts as the ones for which rates were initially filed)
- **Amount : US Dollars 3500 per container**

This is applied to all cargo originating in Asia/SoutheastAsia countries (including Thailand, Malaysia, Myanmar, Cambodia, Vietnam, Japan, Taiwan, Hong Kong, Philippines, Korea, Singapore, Indonesia and China) to all destinations.
