MSC Mediterranean Shipping Company wishes to advise that the Australian Department of Agriculture, Water and the Environment has issued an industry notice alerting all to the conditions associated with the next **Brown Marmorated Stink Bug (BMSB)** season commencing 1st September 2022 (Shipped on Board date basis).

Customers are advised to refer to the [Australian Government website](#) for more detailed information.

Season duration will be any/all shipments between 1st September 2022 until 30th April 2023 (SOB basis). Be aware that Poland is now added to the list of target risk countries. Belarus, Malta, Sweden, United Kingdom and Chile are now classed as 'emerging risk countries'.
