MSC Mediterranean Shipping Company, vous a annoncé dans sa communication **MSC0742022**, qu'elle procèdera à une restauration tarifaire du montant de sa surcharge liée aux expéditions de matières dangereuses pour tous types d'équipements, à compter du **1er Juillet 2022**.

Une erreur s'est introduite dans l'annonce quant à la devise de la surcharge, qui n'est finalement pas en Euros, mais comme suit:

- Depuis **les ports d'Europe du Nord, de l'Atlantique et de la Méditerranée**
- A destination de **tous les ports d'Afrique du Sud**
- **200 US DOLLARS** par EVP pour les marchandises à risque faible
- **500 US DOLLARS** par EVP pour les marchandises à risque moyen
- **750 US DOLLARS** par EVP pour les marchandises à risque élevé

MSC Mediterranean Shipping Company, announced in the communication **MSC0742022**, that we will proceed with a general rate restoration for the amount of surcharges related to shipments of hazardous materials for all equipment types as from **1st July 2022**.

There was an error in the announcement regarding the currency of the surcharge, which is not in EURO but as follows :

- From **Nothern Europe, Atlantic and Mediterranean ports**
- To **Southern Africa**
- **US DOLLARS 200 per TEU** for low risk cargo
- **US DOLLARS 500 per TEU** for medium risk cargo
- **US DOLLARS 750 per TEU** for high risk cargo
